



We have updated this section of our website after the recent cyber-attacks on our website and *phishing* activity. Prospective clients were lured via emails to provide personal data with aim to access their accounts. We urge ALL customers to review this area and contact us if you have any questions

Traders Allied ("TA") maintains certain personally identifiable information regarding clients in its electronic databases to facilitate the processing of transactions on behalf of its clients to comply with rules, regulations and laws. The personally identifiable information stored on TA's network is protected from unauthorized access, treated as confidential, and handled according to the terms of the Traders Allied privacy policy.

TA attests that personally identifiable information and customer information stored on our systems is protected as follows:

- TA's Internet-facing servers are protected from access through firewalls and/or other security devices.
- The firm's critical servers reside on isolated networks that have no direct Internet access.
- TA internal systems that store customer personally identifiable information locks people out of internal systems after a few unsuccessful login attempts.
- Access to shared drives is restricted to active employees and pre-authorized individuals on a "need to know" basis within TA through password-protected logins to the network.
- Encryption technology is employed for data transmissions across public networks and on portable media devices.
- System backups reside either in secure facilities at TA or in secure storage provided by a third party specializing in secure information management.
- Personally, identifying information is generally not stored on laptop computers or other portable devices. Further all data stored on laptop hard drives is encrypted.
- All end-station computers use antivirus software that is regularly updated.
- Operating System security patches are applied to all systems on a regular basis.
- Employees are trained on the requirements to protect personal information.
- TA has adopted written policies and procedures, reasonably designed to protect personally identifiable information.

TA further attests that should a breach occur, management will promptly take action to secure information, mitigate the breach, and notify, on a timely basis, any customers whose personally identifiable information could have been compromised.

Our operation license

Over the recent months, it has come to our attention that clients were lured through the use of our license of operation in order to extract important private personal and financial data from them. Consequently, and as a temporarily measure we have removed our registration details from our website while our investigation into the matter is completed.

Prospective clients can request the registration details of our company with our regulators by email. For this, you must provide your full name and verifiable contact details.

Phishing activities

In recent months, our Security Experts have detected and stopped a series of phishing activities, all with the aim of stealing personal data, such as user names and passwords, as well as private financial information.

We urge all customers not to share any information personal or details of the individual account with anyone, since this information could easily be a cyber-attack on your TA account. In addition, we must remind our clients that sharing such information with third parties is against TA policy and procedures.

Notice of Privacy

WHAT DOES TRADERS ALLIED WITH YOUR PERSONAL INFORMATION?

Traders Allied and / or its affiliates and subsidiaries (" Traders Allied ", "TA", "we", "our" or "we") inform you that your privacy on the Internet is of critical importance to us . The success of our business depends on our ability to maintain the trust of our customers. In the course of our business, we collect information about our users, and we would like to inform you about the type of information we collect, what we do with it and how you can correct or modify the information you entrust to us.

Please note that this policy only applies to websites operated by a member of Traders Allied and not to other organizations or people referred to on such websites through banners or links.

Information collected

When you register for an account with Traders Allied , the following information about you ("your data") will be collected and stored for administrative, service-related and / or legal purposes:

- Personal information, such as names, addresses, personal registration number and email addresses, etc. ("Personal Information"). Financial information ("Financial Information") for the credit evaluation.
- Information about the traffic pattern of the website and IP addresses.

Your data is stored and kept confidential in accordance with the legislation on protection of personal data and its processing applicable in the jurisdiction in which the entity of Traders Allied is located with which you have registered, as explained below in the section "Disclosure of personal data".

Use of cookies

Traders Allied uses cookies to collect information. A cookie is a small data file that a website stores on your computer's hard drive for the purpose of maintaining records when you visit the website.

Cookies allow us to improve your ease of use, for example by remembering your passwords and your viewing preferences, allowing you to visit various parts of the website "only members" without re-registering.

In addition, cookies are used by us to measure the activity on the website and make improvements and updates based on which areas are popular and which are not.

We do not use cookies to retrieve information that was not originally sent in a cookie.

We do not use the information transferred through cookies for any direct purpose of promotion or marketing without your consent.

Use of information collected by Traders Allied

TA uses the personal and aggregated information we collect for multiple purposes.

The information is used:

- Improve the content of the website
- To customize the content and / or the design of the website for each individual user
- Notify users about website updates
- Send newsletters or information about other opportunities that we believe will be of interest to you. We only send if you have indicated you want to go rec ib such information and respect your desire to do so if you communicate such wish.

Personal information is collected when our users provide us with personal information when registering for membership or when requesting an account online. We will limit the collection of Personal Information to whatever is necessary to manage our business in an effort to provide superior service.

The information about the traffic pattern includes information about the web pages to which our users access or visit and how many users log in to our websites daily. This type of information is only used in aggregate form or masked, meaning that the individual user will not be recognised.

We may also use the information we collect to inform you of new products or services available or under consideration, technical issues, customer satisfaction surveys or account updates and related purposes.

Notwithstanding the foregoing, Traders Allied may disclose the following information:

- General information of the client, such as name, address and personal registration number, to companies that carry out administrative tasks for Traders Allied .
- General client data about corporate clients to financial institutions subject to professional secrecy, for marketing purposes and advisory services.
